**ARREST SATURDAY NIGHT** – The Cass County radio traffic went to emergency-traffic-only status for a brief period at midnight Saturday. A deputy was attempting to control a 28-year-old male while making the arrest at 3rd Street and F Street in Eagle. The individual from Lincoln was booked into Cass County Jail. The jail report lists drug possession, obstructing police, resisting arrest and impersonation of a public servant as pending charges. The original traffic stop was for an inoperative headlight.

**ONE VEHICLE ROLLOVERS** – There were two of those Saturday afternoon. Both had fire and rescue responses. The first was during the noon hour. There were two teenagers in the vehicle that rolled at 368th and Mahoney Road. First responders were told there were no serious injuries. Both signed off on transport to a hospital.

The second one was at 3:15pm at 84th and Mill Road. Again, responders were advised of no serious injuries. There was one occupant. The tow truck driver was advised the vehicle was on its top. There was another one vehicle accident Saturday. This one occurred in the early evening. There was a fire and rescue response. There were no injuries. A vehicle crossed the median of Highway 34/75 south of Church Road and into a ditch. There was damage to the construction array in the median.

**ANOTHER LARGE GRASS FIRE** – The Murray Volunteer Fire Department was paged to the 8300 block of Sullivan Lane, east of Beaver Lake, just before noon yesterday for a control burned that had gotten out of control. Mutual aid was requested from Plattsmouth, Nehawka, Avoca, Weeping Water, and Manley. Cass County Emergency Management also responded. Crews remained on location for approximately six and a half hours.

**FRIDAY AFTERNOON ACCIDENTS** – Plattsmouth Fire and EMS were paged to a report of a juvenile struck by a vehicle near the intersection of Chicago and 4<sup>th</sup> Avenues. One patient was transported from the scene to Children's Hospital. A social media posting by a family member of the young girl struck by the car said the child will be OK after suffering scrapes, bruises, and a head injury. The posting thanked all that assisted and cared for the girl. Cassgram contacted the police department Friday afternoon. The spokesman said the report would be available today.

Murray Volunteer Fire and Rescue responded to a two vehicle accident at the intersection of Highway 75 and Murray Road at 1pm Friday. A male was transported from the scene to the Nebraska Medicine Bellevue Health Center with minor injuries. Cass County EMS, emergency management, and deputies assisted. Emergency personnel were on scene for about an hour.

**TRUCK SPOTTED BY TRAIN CREW** in a timbered area north of Plattsmouth – The report was about 4pm Saturday. The law enforcement dispatch said a Union Pacific crew saw a silver pickup in trees. The dispatch advised there was no cross street in the area and the truck may have been traveling alongside the railroad tracks. The truck was on the west side of the tracks.

Police officers and fire department personnel began a search. A searcher then had a visual on an individual beyond the city limits north of Superior Mart. The John Deere Gator of the Plattsmouth Volunteer Fire Department was deployed from the south.

There were no injuries requiring transport to the hospital. Background information was given on a 62-year-old male and a 40-year-old female. A report from the scene advised they had been looking for a dog. The Union Pacific Railroad stopped traffic through Plattsmouth for a time late Saturday afternoon.
