 AT THE 2024 CASS COUNTY FAIR - Tim Zach will perform August 10th. Tim Zach is originally from Glidden, Wisconsin. He was named "Best New Country Act in Nebraska" in 2009. Zach solidified his presence in the Midwest music scene by fronting the band Whiskey Bent from 2010 to 2021. During this time, he shared stages with national acts like Jake Owen, Jimmie Allen, Diamond Rio, Blackhawk, and Sawyer Brown. With Whiskey Bent, Tim and his bandmates released two albums: "Whiskey Bent - How We Roll" and "Whiskey Bent - Blue Collar America," both available on streaming services. In 2021, Zach embarked on a new chapter as a solo artist, performing and recording under his own name. His debut solo album, "Get Your Country On," features the first single "Like Him," which pays tribute to his grandfather.

MAN WANTED ON FOUR WARRANTS in Cass County now in the local jail - 29-year-old Kody Gregg of Nehawka was arrested in Mills County, Iowa earlier this month. He failed to appear for various local court hearings this year. There are nine misdemeanors and one felony on the books in Cass County. The felony is for operating a motor vehicle to avoid arrest. There are two similar misdemeanors plus obstruction and other driving related charges. All total, there are four case numbers that contain the charges. Cass County Attorney Chris Perrone told Cassgram the Mills County arrest was only on the Nebraska charges, there were no charges in Iowa. Bond has been set at \$5,500, ten percent.

MAN ENTERS PLEA in connection with the assault of his father - 37-year-old Seth A. Ketelhut of Walton pled guilty to three charges this week in Cass County District Court. The charges included use of a deadly weapon to commit a felony, a class 2 felony; 2nd degree assault, a class 2A felony; and false imprisonment, a class 3A felony. The state agreed to dismiss charges of kidnapping, use of a firearm to commit a felony, and terroristic threats, all felonies, in exchange for the plea. The warrantless arrest affidavit states a male family member told authorities Ketelhut had arrived at 2360 South 190th Street on the evening of November 4th. The family member stated during the hours that passed, Ketelhut forced him into a chair and would not let him leave. The victim reported he was hit in the head with a PVC pipe, had a steak knife stabbed into the floor around his feet, and had a gun pointed at the floor by his feet while in the chair. Ketelhut is scheduled to be sentenced on July 8th.
