DETAILS RELEASED REGARDING AN ACCIDENT that occurred Monday night near Beaver Lake - According to Cass County Sheriff Robert Sorenson, a white Chevrolet Malibu driven by 49-year-old Johnny Perkins of Garland, TX was westbound on Rock Bluff Road when it failed to yield the right of way at the intersection of Highway 75. This resulted in a collision with a northbound silver Ford Fusion driven by 27-year-old Jaime Ibarra of Omaha. Both drivers were transported by Murray Rescue to a hospital in Omaha for their injuries. The vehicles came to a rest in the intersection forcing emergency personnel to shut down the northbound lanes for an hour.

SENTENCING IN CHILD EXPLOITATION CASE — Nicholas A. Corns, 29, of Plattsmouth, pleaded guilty to possession of a visual depictions of sexually explicit conduct of a child, a class 2A felony. Initially facing two counts, Corns had one count dismissed as part of the plea agreement. He was placed on probation for 36 months, to run consecutively with a probation term in Platte County District Court. Additionally, Corns will be required to register as a sex offender.
Local law enforcement initiated an investigation into Corns after receiving a report from the Platte County, Nebraska Sheriff's Office regarding a child enticement incident in March of last year. Following the obtaining of a search warrant, a phone belonging to Corns was seized and examined.
