WEEKEND ACCIDENTS –
-Thursday night at 8pm a deputy advised dispatch of a two-vehicle accident at northbound Highway 75 and Avenue B in Plattsmouth. The deputy requested Plattsmouth EMS respond for a female party with a possible arm injury. Northbound Highway 75 was reduced to one lane. A female patient was transported to a hospital. Plattsmouth fire, police and county EMS also responded. Law enforcement was on location for nearly an hour.

At the time of the accident Plattsmouth EMS was already responding to two separate medical calls. Murray was requested to assist with the other calls. -Friday night just before 9pm Greenwood Volunteer Fire and Rescue was dispatched to westbound Interstate 80 near the Ashland exit for a one-vehicle accident. One female was transported from the scene. Cass County deputies, Nebraska State Patrol, and county EMS also responded. Crews were on scene for a little over an hour.
