CASE REOPENED – A probation violation is alleged. The sentencing on four counts of misdemeanor motor vehicle homicide was in November 2022. The crash occurred January 31st, 2021.

58-year-old Ronald A. Dubas was the driver of a northbound 2000 Chevrolet GMT-4000 that crossed the centerline on Highway 75 south of Union and struck a 2009 Chevy Cobalt occupied by five people from Topeka, Kansas. The victims killed were ages 4, 5, 21 and 22.

In the charges, the driving violations that unintentionally caused the deaths: careless driving, driving left of center. Alcohol was not involved. The pain of the uncertainty of the cause of the crash was a predominant point expressed by the judge, the prosecuting attorney, the defense attorney. -24 months on probation (4 counts, served concurrently)

-\$1000 in fines plus court costs

-84 days in jail that include that-day sentences on the birth dates of the victims and the anniversary of the collision. Most of the 84 day sentence is a 60 day sentence at the end of the probation term that can be waived by the court if probation is completed satisfactorily.

-24 months with no driving privileges of any vehicle.

Driving is the alleged probation violation.

Probation officers were at the Dubas residence for a routine check in February when both officers observed a vehicle pull into the driveway and Dubas exit from the driver's side.

A report was submitted to the county attorney's office. A motion to revoke probation was filed and a warrant was issued in late March. Dubas was arrested by LaVista police and posted \$3500 bond (10%) in Sarpy County. In the hearing yesterday, Judge Partsch appointed the public defender and set the pretrial hearing date for June 18th.

OVER 600 MILES of non-hard surfaced roads are on the maintenance

OVER 600 MILES of non-hard surfaced roads are on the maintenance schedule of the Cass County Department of Roads – The 2024 bidding process for material for those roads has been completed.

Cass County Road Superintendent Lenny Thorne said enough available supply to meet the county's needs is an annual problem. "Last year we used 95,542 tons of rock," said Thorne.

That's why he recommended that both aggregate bids received be accepted.

-Whetrock quarry bids: clean rock- \$21.25 per ton; crush and run- \$17.25 per ton; riprap- \$38 per ton

-Martin Marrietta: clean rock- \$28.05; crush and run- \$20.50; riprap-\$44.85

\$44.85 Thorne said the bids were roughly a dollar higher than last year's. Three haulers were approved. They are Green Thumb LLC, Wessels Trucking, and Westover Rock and Sand.
